**Addendum No. 1 to Airport Authority of India's ("Authority") request for proposal number AAI/KID/OMD/AHM/2018[2018\_AAI\_19451\_1] dated 14<sup>th</sup> December, 2018 for operation, management and development of Sardar Vallabhbhai Patel International Airport at Ahmedabad, Gujarat ("RFP").**

Pursuant to Clause 2.10 of the RFP, the Authority hereby amends the RFP as follows:

S No.	Reference to Existing Clause/Provision	Revised Clause/Provision
1.	Clause 1.2.1(a)(i)	Clause 1.2.1(a)(i) shall stand substituted as follows:  "The Bidder may, prior to, as the case may be, visiting the Airport, accessing the Data Room, and/ or participating in the pre-Bid conference, nominate, by way of an email sent to <a href="mailto:edkid@aai.aero">edkid@aai.aero</a> , up to a maximum of 10 (ten) persons (in aggregate) for the said purpose(s) (" <b>Nominated Entity(ies)</b> "). For the avoidance of any doubt, Nominated Entities shall not include a Bidder's directors, employees, retainers, officers or partners."
2.	Clause 1.2.1(a)(ii)	Clause 1.2.1(a)(ii) shall stand substituted as follows:  "Each Nominated Entity shall also separately submit the NDU (in the format specified in Appendix-VII) in order to be eligible to visit the Airport, access the Data Room and/ or participate in the pre-Bid conference. Such NDU shall be sent by the Bidder via email to <a href="mailto:edkid@aai.aero">edkid@aai.aero</a> ."
3.	Clause 1.2.1(b)	It is clarified that Bidders are requested to upload a <b>single PDF</b> , comprising scan copies of: (i) the NDU and Power of Attorney to be submitted under Clause 1.2.1(a), and (ii) the payment receipt generated (with SWIFT code, if applicable) under Clause 1.2.1(b). This single PDF shall be uploaded in the <b>Clarification window</b> in the CPP Portal.  In such cases, the Bidding Documents shall be shared by AAI as a response to the clarification sought.

		<p>Note: The Bidder shall ensure submission of this single PDF comprising scan copies of: (i) the NDU and Power of Attorney to be submitted under Clause 1.2.1(a), and (ii) the payment receipt generated (with SWIFT code, if applicable) under Clause 1.2.1(b). <b>from 23 January 2019 to 31 January 2019 before 1500 hrs in CPP Portal under “My Tenders / Proceed for NDA Submission” tab.</b></p>
