## **India Economic News**

Ind-Ra raises GDP growth forecast to 7.4%

India Ratings and Research (Ind-Ra) has scaled up its projections for economic growth to 7.4%, from the earlier 7.1%, for 2018-19 on expectations of strong agricultural and industrial growth.



Earlier, the International Monetary Fund had projected India's economy to grow at 7.4 % in FY19, while the World Bank expects the economy to grow at 7.3 %.

The Union Budget for 2018-19 had projected nominal Gross Domestic Product (GDP) to grow at 11.5%. By comparison, Ind-Ra expects nominal GDP to grow at 10.9%. Ind-Ra has raised its forecast for gross value added (GVA) by agriculture to 3% in FY19, up from its earlier forecast of 2.7 %, on account of a good monsoon.

India ranks 130 in Index of Economic Freedom, up by 13 spots

India has jumped 13 places in the last one year to earn 130<sup>th</sup> spot in the latest annual Index of Economic Freedom released by a top American think-tank. In 2017, India with a score of 52.6 points was ranked at 143 among 180 countries, according to the Index of Economic Freedom.



India's overall score has increased by 1.9 points to 54.5, led by improvements in judicial effectiveness, business freedom, government integrity, and fiscal health. India is ranked 30<sup>th</sup> among 43 countries in the Asia Pacific region.

Economic liberalization measures, including industrial deregulation, privatization of enterprises state-owned and reduced controls on foreign trade and investment, that began in the early 1990s, accelerated India's diverse growth. economy encompasses traditional village farming, modern agriculture, handicrafts, a wide range of modern industries, and a multitude of services.

# 60% of India's GDP to come from AI, other digital services by 2021

By the year 2021, around 60% of the country's Gross Domestic Product (GDP) is expected to be derived from digital products and services created reated through the use of technologies such as Artificial Intelligence (AI), the Internet of Things and cloud computing, among others.



According to the study commissioned by Microsoft, digital transformation will add an estimated \$154 billion to India's GDP by 2021. The study indicates that 90% of organizations in India are in the midst of their digital transformation journey.

The central government has formed a committee on Artificial Intelligence AI to suggest a technical framework or platform for the emerging technology. It is chaired by P P Chakraborty, professor at IIT, Kharagpur, and has representatives from Google, Microsoft, NVIDIA , TCS and Nasscom, the apex association of the Information Technology (IT) sector, beside the National Informatics Centre and the Ministry of Electronics and IT.

# Remittances to India rebound in 2017, grow 10% to US\$ 69 billion

According to the World Bank, India has retained its position as the top remittances receiving country with diaspora sending about USD 69 billion back home in 2017. Remittances to India rose 9.9% in 2017 after declining 8.9% in 2016 to \$62.7 billion, the World Bank's migration and remittances report said.



India was followed by China (\$64 billion), the Philippines (\$33 billion), Mexico (\$31 billion), Nigeria (\$22 billion), and Egypt (\$20 billion) as the top countries receiving remittances.

Stronger growth in the European Union, Russian and the US propelled overall remittances to developing countries to a new record of \$466 billion in 2017, up 8.5 % over 2016. The rebound in remittances valued in US dollars was also helped by higher oil prices and a strengthening of the euro and the ruble.

Remittances are likely to continue growing in 2018, aided by stronger economic conditions in advanced economies (particularly the US) and an increase in oil which is beneficial prices, to Gulf Cooperation Council countries. Flows to developing countries are expected to grow 4.1 % to reach \$485 billion in 2018.

# India's spices exports rise 20% in April-Dec 2017

India exported about 797,000 tonnes of spices and spice products worth USD 2.04 billion during April-December 2017, an increase of 20% in volume and 9% in value.



Large shipments of small cardamom, cumin, garlic, asafoetida, tamarind and other seeds propelled an increase both in volume and value. The export of value added products like curry powder, mint products, spice oils and oleoresins also increased in volume and value.

By exporting 353,400 tonnes, chilli earned USD 406 million in April-December 2017 as against 260,250 tonnes and USD 433 million during the same period in 2016. Cumin was the second-most exported spice, recording an increase of 15% in volume and 19% in value. A total volume of 104,260 tonnes of cumin fetched USD 220 million as against USD 185 million and 91,024 tonnes.

Small cardamom registered maximum export growth both in terms of value and volume during the period. A total of 4,180 tonnes of this spice, valued at USD 57 million, was exported in April-December 2017 as against 2,910 tonnes worth USD 37 million in the corresponding period in 2016. There was an increase of 44% in volume and 53 % in value.

Mint products accounted for 16,500 tonnes in volume and USD 278 million in value as compared to 14,850 tonnes and USD 206 million in 2016, an increase of 11% in volume and 35% in value respectively.

# India exports record 395,000 tonnes of coffee in Financial Year 2017-18

Coffee exports from India, Asia's third-largest producer and exporter, reached an all-time high at 395,000 tonnes in the 2017-18 fiscal on strong demand for instant coffee, according to state-run Coffee Board. India had exported 355,000 tonnes of coffee during the previous year.

The coffee exports were at all-time high in FY 2017-18 because of increased shipments of value-added products, especially instant coffee. There was an increase in instant coffee output because of improved production capacity with setting of up new units.




India largely exports Robusta variety of coffee, the volumes of which also showed a jump in the 2017-18 fiscal in view of strong demand and record domestic production. The top three export destinations are Italy, Germany and Russian.

Medical tourism witnesses a substantial increase from 2014 to 2016

The Ministry offers financial support as Marketing Development Assistance for Publicity and for organizing Wellness and Medical Tourism Promotion shows as well as workshops/events/seminars. A film on Medical Tourism has been produced in association with BBC and is used at various fora for promotional purposes.



Medical and Medical attendant visa has been introduced to streamline and ease the travel process of Medical Tourists. The e-tourist visa regime has also been expanded to include medical visits as well. It has been decided to set up facilitation counters at the major airports of Delhi, Mumbai, Chennai, Kolkata, Hyderabad and Bengaluru for tourists arriving on Medical Visas.

Apart from the above, the Department of Commerce (DOC) and Services **Export** Promotion Council (SEPC) has launched a Healthcare Portal www.indiahealthcaretourism.com in English, Arabic, Russian and French languages as a single source platform providing comprehensive information medical travelers on the top healthcare institutions in the country.

Number of Foreign Tourist Arrivals (FTAs) for medical tourism has been increasing yearly from 184,298 in 2014 to 427,014 in 2016.

Delhi's Indira Gandhi International Airport breaks into world's top 20 busiest airports

New Delhi's Indira Gandhi International Airport has jumped six notches to break into the league of the top 20 busiest airports in the world for 2017 in terms of traffic volumes. The GMR-group-run New Delhi airport jumped from 22<sup>nd</sup> rank in 2016 to 16<sup>th</sup> rank, solidifying its status as one of the fastest growing airports in the world for passenger traffic, as per the Airports Council International (ACI).



The ranking is based on the preliminary passenger traffic results for the most-traveled airports in 2017, released by the ACI. Hartsfield-Jackson Atlanta International Airport (ATL) was ranked the busiest airport in the world with 103 million passengers (both departing and arriving). Followed by International Airports of Beijing (96 mil),

Dubai (88 mil), Tokyo (85 mil), Los Angeles (84.5 mil) and Chicago (80 mil)

ACI's World Airport Traffic Forecasts also predicts that India will represent the third largest aviation market, in terms of passenger throughput, after the US and China by 2020.

Delhi, the country's busiest airport for passenger traffic, grew by 14.1% year-over-year at 63.45 million, pushing it up from 22<sup>nd</sup> to the 16<sup>th</sup> busiest airport in the world. Even with this rapid growth in throughput, Delhi was also ranked first in Airport Service Quality for airports above 40 million passengers per annum along with the Mumbai airport.

Besides, Kolkata, Hyderabad, Bengaluru and Chennai were also ranked among the fastest growing airports in the world with an year-over-year growth of 26.9%, 19.6%, 12.9% and 10.5%, respectively during 2017.

# India launches Digital Initiative for Ease of Farm Export

On 3<sup>rd</sup> April, Union Commerce & Industry and Suresh Civil **Aviation** Minister, Prabhu launched digital initiatives **Export** Inspection Council (EIC) for ease of farm export. EIC is the official export certification body of Government of India and has launched this flagship project of Digital India Initiative to keep pace with changing dynamics of the world.



In order to continue the vision for credible inspection and certification and to strengthen the confidence on Indian produce,three portals have been developed to reduce transaction time and cost in a transparent

manner. To provide fast, efficient and transparent services for ease of doing business in all sectors the complete export food chain has been integrated in this digital platform.

# Gems and jewellery council sets US\$ 100-billion target by 2025

The All India Gems & Jewellery Domestic Council has set a target of USD 100 billion by 2025 for the domestic gems and jewellery sector. At present, the domestic gems and jewellery sector is estimated at USD 75 billion.



India's gems and jewellery business is a sterling example of the government's 'Make-in-India' initiative, contributing around 7% of the country's GDP. It provides jobs to more than 4.6 million people of the country, thus making significant contribution to the country's socioeconomic framework. The All India Gems & Jewellery Domestic Council (GJC) has drawn up a roadmap for adding 2 million new jobs in the gems and jewellery sector, including 40% of the new jobs for women.

Ambassador attends official ceremony of takeover Serbian TAFE's of tractor manufacturing company IMT. H.E. Mrs. Narinder Chauhan, Ambassador of India attended the official contract signing ceremony for the sale of Serbian tractor manufacturer Industrija Masina i Traktora (IMT) to Indian company Tractors And Farm Equipment Limited (TAFE) on 11 April 2018. The ceremony was officiated by Ms Ana Brnabic, Prime Minister of Serbia and Mr Branislav Nedimovic, Serbian Minister of Agriculture.



In the bidding process on 2<sup>nd</sup> April, the Indian company TAFE had successfully taken over the Serbian tractor manufacturer, thus acquiring rights of the Intellectual Property of IMT, which includes the Brand, Designs, IPR and the right to use the real estate at Jarkovac, a city 75 kms from Belgrade.



TAFE has been IMT's partner since 1962 and is the oldest player in the region with annual sales of around 750 tractors in the region. TAFE intends to manufacture tractors under the IMT brand, with 50% of their parts to be made in Serbia- the engine and other key components will come from India while the cabin, battery, gear and tires will be locally sourced. The Indian company has said it will produce IMT tractors for Southeast Europe as well as other markets with whom Serbia has Free Trade Agreements. TAFE plans to produce around 5,000 tractors in the first five years to meet the needs of the local and regional markets.

Serbia abolishes visas for Indian nationals holding ordinary passport: The Government of the Republic of Serbia abolished visas for Indian nationals vide official notification No. 3059 published in the Official Gazette of the Republic of Serbia on 25<sup>th</sup> August 2017.



As per the Gazette Notification, from 02 September 2017, Indian nationals holding

ordinary passport are allowed to enter, transit and stay in the territory of the Republic of Serbia for a duration up to thirty (30) days from the date of entry within a period of one year.

e-Visa to Serbian nationals: The online e-Visa is an electronic authorization that allows citizens of Serbia to travel to and within India. Electronic Visa was extended to Serbia in February 2016 for tourism purpose. However, w.e.f. 01 April 2017 thescope has been expanded and now e-Visa allows its holder to visit India for tourism, business and medical purposes. Applicants may apply online minimum 4 days in advance of the date of arrival with a window of 120 days. The validity of e-Visa will be 60 days from the date of arrival in India. e-Visa is non-extendable with double entry on e-Tourist Visa and e-Business Visa. Triple entry will be permitted on e-Medical Visa which can be extended up to 6 months bv the **Foreigners** Regional Registration Officer (FRRO)/Foreigners Registration Officer (FRO) concerned on the merits of each case.

Use of e-Visa facility by Serbian nationals is on the rise and nearly 1200 Serbian nationals utilized the facility during the period January to December 2017.

e-Visa is valid for entry through 24 designated Airports (i.e. Ahmedabad, Amritsar, Bagdogra, Bengaluru, Calicut, Chennai, Chandigarh,Cochin, Coimbatore, Delhi, Gaya, Goa, Guwahati, Hyderabad, Jaipur, Kolkata, Lucknow, Mangalore, Mumbai, Nagpur, Pune, Tiruchirapalli, Trivandrum & Varanasi) and 3 designated seaports (i.e. Cochin, Goa, Mangalore). However, the foreigner can take exit from any of the authorized Immigration Check Posts (ICPs) in India.

The facility of e-Visa is valid only for a maximum of two visits in a calendar year and is in addition to the existing Visa services provided by the Indian Embassy.

Eligibility criteria:

- Passport should be valid for at least six months from the date of arrival in India.
- The passport should have at least two blank pages for stamping by the Immigration Officer.
- Applicant should have return ticket or onward journey ticket, with sufficient money to spend during his/her stay in India.
- Not available to individuals endorsed on Parent's/Spouse's Passport i.e. each individual should have a separate passport.

Serbian nationals who hold Diplomatic/Official passports will continue to enjoy visa free entry into India. Not available to International Travel Document Holders.
