India Economic News

India to grow at 7.3% in 2019 and 7.5% in 2020

India is projected to grow at 7.3 % in 2019 and 7.5 % in 2020, supported by the continued recovery of investment and robust consumption, thus remaining the fastest growing major economy of the world, according to the IMF. In 2018, India's growth rate was 7.1%, as against China's 6.6%.



Growth in India, as per the IMF is expected to stabilise at just under 7% over the medium term, based on continued implementation of structural reforms and easing of infrastructure bottlenecks. In the IMF World Economic Outlook, it is stated that India will continue implementation of structural and financial sector reforms with efforts to reduce public debt which will remain essential to secure the economy's growth prospects. Important steps have been taken to strengthen financial sector balance sheets, including through accelerated resolution of non-performing assets under a simplified bankruptcy framework.

India's core sector growth rises 4.7% in March

The core sector of the economy recorded 4.7% growth in March, the highest in five months, with impressive recoveries in the refinery products segment and cement production. With this, the annual core sector growth for FY19 was 4.3%.



Data released by the Ministry of Commerce and Industry showed that the eight segments — coal, crude oil, natural gas, refinery products, fertiliser, steel, cement and electricity — witnessed growth recoveries in March after weakening for four-straight months. Refinery products, which command almost 30% of the core sector index, rose by 4.3% in March.

Coal output has disproportionately risen since January when growth was just 1.7%. The coal production rose by 9.1% in March, up from 7.4% in February. In the

infrastructure space, steel output growth 6.7 % in March -- the highest in three months. On the other hand, cement production jumped to an 11-month high of 15.7% in March. Finally, fertiliser production growth gained pace in March, rising 4.3 %, up from 2.5 % in February.

Exports to reach over US\$ 330 billion in 2018-19

India's exports are expected to reach USD 32.38 billion in March, the highest in any month so far, on account of healthy growth in sectors such as pharmaceuticals, Commerce and Industry Minister Suresh Prabhu. He said that exports would cross USD 331 billion mark in the 2018-19 fiscal year.



For the "first time", India has crossed USD 19 billion figure in pharma exports this fiscal. India's exports have been declining in recent years, but in 2018-19 they will most probably reach record levels, even at a time when there is a worrying scenario in the world trade front.

The outbound shipments are growing because of concerted efforts by the ministry in the last one year. A matrix has been created between every product and every geography. Secondly, Indian industry has done a series of road shows which helped exports in regions such as Africa and Latin America. India is recording a healthy growth in exports

despite the fact that countries are putting barriers and following protectionist measures.

India's exports grew by 8.85 % to USD 298.47 billion during April-February 2018-19. Since 2011-12, India's exports have been hovering at around USD 300 billion. During 2017-18, the overseas shipments grew by about 10 % to USD 303 billion.

India's services exports rise 5.5% to US\$ 15.6 billion in February 2019

India's services exports rose 5.5% to USD 16.58 billion in February 2018-19 from USD 15.71 billion in the same month a year ago, data from the Reserve Bank showed. However, the exports during February 2019 were lower than January's USD 17.75 billion.



Services imports in February 2018-19 declined by 3.3 % to USD 9.81 billion, compared to USD 10.14 billion in the year-ago month, as per the RBI data on 'India's International Trade in Services: February 2019'. The imports stood at USD 11.3 billion during January this year.

India highest recipient of remittances at USD 79 billion in 2018

India retained its position as the world's top recipient of remittances with its diaspora sending a whopping USD 79 billion back home in 2018, the World Bank said in a report. India was followed by China (USD 67 billion), Mexico (USD 36 billion), the Philippines (USD 34 billion), and Egypt (USD 29 billion).



Over the last three years, India has registered a significant flow of remittances from USD 62.7 billion in 2016 to USD 65.3 billion 2017. Remittances grew by more than 14 % in India, where a flooding disaster in Kerala likely boosted the financial help that migrants sent to families.

According to the report, remittances to low-and middle-income countries reached a record high of USD 529 billion in 2018, an increase of 9.6 % over the previous record high of USD 483 billion in 2017. Global remittances, which include flows to high-income countries, reached USD 689 billion in 2018, up from USD 633 billion in 2017.

The upsurge was driven by stronger economic conditions in the United States and a pick-up in oil prices, which had a positive impact on outward remittances from some GCC countries. The Gulf Cooperation Council (GCC) is a regional inter-governmental political and economic

bloc of Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the UAE.

M&M to deploy 50 electric vehicles on Uber platform



Automaker Mahindra & Mahindra Ltd announced the deployment of 50 of its Electric Vehicles (EVs) to Uber, an on-demand ride-sharing company, to provide zero emission mobility here. Earlier, Mahindra had announced its collaboration with Uber to explore the deployment of electric vehicles (EVs) on its platform in several cities across the country.

To begin with, the companies would deploy 50 Mahindra EVs in the city and scale up over a period of time. Mahindra's electric vehicles on the Uber platform would include the e2oPlus hatchback and the eVerito sedan. To make this model sustainable, Mahindra worked with public and private players who had initially set up over 30 common use charging points across multiple locations.

Mahindra's collaboration with Uber is aimed at accelerating the large-scale adoption of electric vehicles on shared mobility platforms, thereby driving a positive change in daily commute. As part of this collaboration, both companies

would also explore the deployment of Mahindra electric vehicles in other cities. Through this tie-up, driver partners on the Uber app can avail themselves of a package which would include Mahindra electric vehicles. The package would be priced competitively with attractive financing and insurance premiums as well as comprehensive maintenance packages from Mahindra and its associates.

ICRA projects 7-7.5 GW solar power capacity addition in 2019-20

Rating agency ICRA said that it has estimated 7-7.5 GW solar power capacity addition during the financial year 2020, which includes 1 GW of rooftop solar. The estimate is based on tendering and awards of projects in the last 12-15 months.



By contrast, solar capacity addition is estimated to have remained subdued at around 6 GW to 6.5 GW in the financial year 2018-19 due to weak trend in award of solar projects in the calendar year (CY) 2017. Tendered project awards for solar PV (photovoltaic) projects during CY 2018 stood at about 11 GW against 4.5 GW in CY 2017, providing a healthy pipeline for capacity addition over the next 2-year period.

Domestic air passenger volume crosses 171 million in FY19

Domestic air passenger volume grew 14.25 % to 171.25 million in fiscal 2019 over the previous year. In FY18, the passenger volume had clipped at a higher 18.3 % to 146.84 million.



Budget carrier IndiGo continued to be the largest player with a market share of 46.9 % ferrying 5 million passengers during the month, while its closest rival SpiceJet was a distant second with 13.6% traffic pie as its ferried 1.58 million passengers in the reporting month.

The national carrier Air India managed to get the third spot after IndiGo and SpiceJet in passenger volume, carrying 1.52 million passengers with a market share of 13.1 % in March. The passenger load factor in the month has shown falling trend compared to February due to the end of the vacation period.

SpiceJet continues to clock the highest average seat occupancy at 93 % while smaller rival GoAir topped the on-time performance chart for the sixth consecutive month in March at 95.2 %.

Royal Enfield enters South Korean market

Niche bike maker Royal Enfield said it has forayed into the South Korean market. The company, part of Richer Motors, has entered the country by opening its first flagship store in Seoul with Vintage Motors (Kiheung International) as its official distributor partner.



Korea is an important chapter in the growth story and the company. The strategic announcement is in line with Royal Enfield's focused international thrust of leading and expanding the global mid-sized motorcycle segment (250-750cc). The company has already entered various markets globally over the last few years.

Icra expects domestic tyre demand to grow 7-9%

The domestic tyre demand is expected to grow in the range of 7-9 % over the five year period between 2018-19 to 2022-23, according to estimated by rating agency Icra. With a stable demand outlook and strong credit profile, the domestic tyre makers will continue to invest in capacities.



Based on announcements, the industry is likely to witness a capacity addition of over USD 3.5 billion in the next three years. The revenue growth for tyre industry is pegged at 14-15 % for 2018-19, with operating margin and net margin of 14 % and 7 %. For 2019-20 to 2021-22, revenue growth is projected at 9-10 % with operating and net margins at 14-15% and 6-7%.
